PRIVACY POLICY

BACKGROUND:

Lease-Pilot Limited ("we", "us", or "our") understands that your privacy is important and that you care about how your personal data is used. 6. WHAT DATA DO YOU COLLECT AND HOW?

We collect personal data through forms on Our Site, communications you send to us, and automated technologies (like cookies). This may include:

- 6.1 Identity data (name, business name)
- 6.2 Contact data (email address, telephone number)
- 6.3 Technical data (IP address, browser, device type)
- 6.4 Usage data (pages visited, interactions with ads)
- 6.5 We do not knowingly collect special category data or data relating to children.

7. HOW DO YOU USE MY PERSONAL DATA?

We use your personal data to:

- 7.1 Process review requests (legal basis: contract)
- 7.2 Connect you with a solicitor (contract)
- 7.3 Maintain records for audit or legal compliance (legal obligation)
- 7.4 Improve our service (legitimate interests)
- 7.5 Market to you via Google Ads and remarketing tools (consent)
- 7.6 We do not send direct marketing emails unless you've opted in.

8. HOW LONG WILL YOU KEEP MY PERSONAL DATA?

We retain data for:

- 8.1 Appointment and transaction data: 6 years (legal/accounting compliance)
- 8.2 Technical and analytics data: up to 14 months
- 8.3 Marketing consents and preferences: until withdrawn

9. HOW AND WHERE DO YOU STORE OR TRANSFER MY PERSONAL DATA?

We store your data in the UK or EEA. Where third-party services (e.g. Google) transfer data internationally, we rely on standard contractual clauses or adequacy decisions.

10. DO YOU SHARE MY PERSONAL DATA?

We may share your data with:

- 10.1 Independent solicitors (to deliver the requested service)
- 10.2 Payment processors (to handle transactions)
- 10.3 Advertising providers (e.g. Google, via tags and cookies)
- 10.4 Technical service providers (e.g. hosting, analytics)
- 10.5 We do not sell your data. We only share what's necessary and ensure third parties protect it appropriately.

11. HOW CAN I CONTROL MY PERSONAL DATA?

You can:

- 11.1 Opt out of cookies via our cookie banner
- 11.2 Unsubscribe from emails (if subscribed)
- 11.3 Contact us to exercise your rights (Part 15)

12. CAN I WITHHOLD INFORMATION?

Yes, but some services may be limited if you choose not to provide necessary data or block functional cookies.

13. HOW CAN I ACCESS MY PERSONAL DATA?

You may request access to your data by emailing us. We'll respond within one month. We may ask for ID before responding.

14. HOW DO YOU USE COOKIES?

We use cookies for:
